Further details here https://www.thevaccinators.co.uk/</li> <li>Staff are encouraged to notify the setting when they have completed their vaccine course (to enable long term planning) – please note staff do not have to share medical information with their employer if they do not wish to</li> <li>Staff will be encouraged to take Lateral Flow Tests twice a week and to share results with the setting and report them to the national system online</li> <li>Staff/children that meet the criteria of clinically vulnerable or clinically extremely vulnerable, have a risk assessment completed to identify any suitable control measures that must be in place to keep them safe in the setting. Spread of Covid 19 within the setting - hygiene	Impact on educational provision for pupils	<ul> <li>The setting has a suitable supply of soap and access to warm water for washing hands.</li> <li>Appropriate controls are in place to ensure the suitable sanitisation of children's hands on arrival at the setting, following outdoor play, before meals and following the use of toilets.</li> <li>Monitor the use of hand sanitiser with young children to ensure it is not ingested</li> <li>Staff will encourage children to learn and practise good hygiene habits through games, songs and repetition.</li> <li>Staff will model the use of "catch it, bin it, kill it" to the children. Spread of Covid- 19 within the setting – ventilation	Impact on educational provision for pupils	<ul> <li>Keep windows open as much as possible to ensure good ventilation throughout the setting. Thought should also be given to thermal comfort e.g. use of higher level windows or opening windows when the room is not in use</li> <li>Identify any poorly ventilated areas and take steps to ventilate these as well as possible</li> <li>Plan to use outdoor space as often as possible during the day</li> <li>Consider referring to Health and Safety Executive guidance on ventilation and air conditioning during the coronavirus (COVID-19) pandemic</li> </ul>	ssment	All staff	Ongoing	
Spread of Covid- 19 within the setting – enhanced cleaning	Impact on educational provision for pupils	<ul> <li>Follow the guidance for cleaning in non-healthcare settings <u>COVID-19</u>: cleaning of non-healthcare settings outside the home - GOV.UK (www.gov.uk)</li> <li>Regular cleaning procedures should be in place across the site, particularly in communal areas and at touch points including:         <ul> <li>Taps and washing facilities,</li> <li>Toilet flush and seats, door locks, bins, sanitary bins, lavatory brush and toilet roll dispenser</li> <li>Door handles and push plates,</li> <li>Handrails on staircases and corridors,</li> <li>Lift and hoist controls,</li> <li>All areas used for eating must be thoroughly cleaned at the end of each break, including chairs, door handles.</li> <li>Telephone equipment,</li> </ul> </li> </ul>		KM + H&S committee	Ongoing

		<ul> <li>Keyboards, photocopiers and other office equipment, tables and chairs.</li> <li>Where possible ensure surfaces are kept clear to enable cleaning</li> <li>Consider having clear signage in each room laminated (so that it is wipeable) detailing touch points.</li> <li>If you have been informed that someone has tested positive with covid-19 then any area/room they have accessed should undergo a thorough clean.</li> <li>Ensure the COSHH risk assessment for cleaning/caretaker activities has identified the correct process and PPE to be worn.</li> <li>Surfaces should be washed with hot soapy water, then sprayed with disinfectant and left for at least 60 seconds (or the manufacturers recommendations should be followed) prior to wiping. Care should be taken to ensure children cannot access the surfaces during this time.</li> </ul>	ssnent			
Child or staff member displaying symptoms whilst in the setting	Impact on educational provision for pupils	<ul> <li>Ensure that all staff are aware of the symptoms of Covid-19 and are alert to how to respond:         <ul> <li>A high temperature – this means the child feels hot to touch on their chest or back (you do not need to measure their temperature)</li> <li>A new, continuous cough – this means coughing a lot for more than an hour, or 3 or more coughing episodes in 24 hours (if</li> </ul> </li> </ul>	Information sharing with parents/carers and staff	КМ	Start Sep. 21

	<ul> <li>a child usually has a cough, it may be worse than usual)</li> <li>Loss or change to sense of smell or taste – this means the child noticed they cannot smell or taste anything, or things smell or taste different to normal</li> <li>Adults who are displaying symptoms should self-isolate and get a PCR test. A poster will be displayed at all entrances advising adults of this.</li> <li>If a member of staff has tested positive using a home based or workplace testing Lateral Flow Device test they should book a polymerase chain reaction (PCR) test immediately to confirm the result and self-isolate until that result is available.</li> <li>If a child or staff member develops symptoms compatible with coronavirus, they should rapidly be sent home and advised to get a PCR test. If the test is positive they should self-isolate for 10 full days from the day after their symptoms started. Their fellow household members will be advised to self-isolate for 10 days. All children and staff will be directed to the NHS Test and Trace portal if they display symptoms of coronavirus to book a test and tracing of contacts to take place: https://www.nhs.uk/conditions/coronavirus-covid-19/testing-and-tracing/</li> <li>The isolation period includes the day the symptoms started and the next 10 full days</li> </ul>	sment

		<ul> <li>If any of the individual's household members are also present at the setting they will need to be sent home at the same time</li> <li>The manager will support the family/staff member and ensure the outcome of the test in passed to the setting without delay.</li> <li>Identify an area where any child displaying symptoms can be isolated whilst they are waiting for collection. Ensure a familiar adult, with appropriate PPE stays with them.</li> <li>Ensure that all children have up to date contact details to enable parents/carers to be contacted quickly.</li> <li>Consider how the isolation area can be easily cleaned after use.</li> </ul>	ssment
